
### THE TASK:

Re-invent or re-imagine one (1) Universal Classic Monsters character from the list below. The design must be your original concept and cannot be based on an actor’s likeness or another existing character design (i.e., a movie remake, comic book, video game, TV show, toy product, etc.).



### TWO WAYS TO DESIGN YOUR CHARACTER:

- Provide an illustration of your character design.
  - Must include full body view of the character and costume (if any) and a separate close up of face (see example).
  - Must include the character name from the list above that you are basing your design on.
  - Can be either full color or black and white on 8.5” x 11” letter-size paper.
- Submit a one-page written description of your character idea.
  - Must include detailed information about the look of the character’s face, skin, color, hair, posture, costume, props (if any).
  - Must include the character name from the list above that you are basing your design on.
  - Must be typed in easily readable font on 8.5” x 11” letter-size paper.

### HOW TO SUBMIT:

To submit your design for consideration in the contest, you must mail one (1) copy of either your illustration or written description to the address shown on the Official Contest Rules.

Your design must be accompanied by a signed copy of the contest rules and include your name, daytime telephone number, address, city, state, zip code, age and email address. **Submittals must be received by 5:01pm PT on Monday, July 1, 2013** to be considered for the contest. Your design submittal will not be returned to you after the contest, so send a copy - not the original.

The "Halloween Horror Nights 2013 Character Design Fan Contest" (the "Contest") begins at 2:00 p.m. PT on June 3, 2013 and ends at 5:01p.m. PT on July 1, 2013 ("Contest Period"). This Contest is sponsored by Universal City Studios LLC dba Universal Studios Hollywood ("USH") (the "Sponsor").

1. **ELIGIBILITY:** Contest is open only to permanent, legal U.S. and D.C. (excluding Alaska, Hawaii, and Puerto Rico) residents who are eighteen (18) years of age or older and have reached the age of majority in their state of residence as of the time of entry. Officers, directors, and employees of Sponsor and its parent, subsidiary, affiliated and joint venture companies, advertising and promotion agencies, and any other entity involved in the development or administration of this Contest, as well as members of such persons immediate families and households (including children, spouses and siblings and/or other people living in the same households as such persons, whether related or not), are not eligible to participate or win. By participating, entrants agree to be bound by these Official Rules and the decisions of Sponsor and its representatives, which are binding and final on all matters relating to this Contest. Sponsor reserves the right (but is not obligated) to verify eligibility qualifications of any entrant or winner.
2. **HOW TO ENTER:** Beginning at 2:00p.m. PT on June 3, 2013 and ending at 5:01p.m. PT on July 1, 2013 (the "Submission Period"), contestants are invited to submit original character design concepts (the "Character Design"), as set forth on the attached Universal Studios Halloween Horror Nights 2013 "Design a Character" Contest Instructions, to a judging panel selected by the Sponsor for consideration in the Contest. Participant must 1) print out and sign the Agreed and Acknowledged section at the end of these Official Rules (including participant's name, daytime telephone number, address, city, state, zip code, age and email address), and 2) submit one (1) copy of participant's character design concept. The Character Designs must arrive at the designated address hereinabove by 5:01 p.m. PT on Monday, July 1, 2013.

Only one (1) person may be considered the originator (creator) of the Character Design as set forth as the "participant" in the Official Entry form, and only the submitting participant of the winning Character Design shall be eligible to receive the First Prize. For any participant's entry to be valid and in order for their Character Design to be considered, participant must acknowledge reading, accepting, and agreeing to the terms and conditions set forth in these Official Rules and the Terms of Submission. Participant's Character Design that participant submits in connection with participant's entry (collectively "Submission") must be original, truthful and unpublished. See below for complete Terms of Submission.

**SUBMITTAL INSTRUCTIONS:** Design an original character that responds to the instructions as set forth on the Website and in these Official Rules (including, without limitation, the Terms of Submission and the Contest Instructions). Among other things, the Character Design must be submitted in the format set forth in the Universal Studios Halloween Horror Nights 2013 "Design a Character" Contest Instructions.

**LIMIT ONE (1) ENTRY PER PERSON.** All entries must be received by no later than 5:01 p.m. PT on Monday, July 1, 2013. Entries generated by script, macro or other automated means are void. All entries become the property of Sponsor and will not be acknowledged or returned. Please note that this is not an application for employment.

3. **TERMS OF SUBMISSION:** By entering, you represent and warrant that (i) your entire Submission is an original work by you and you have not copied or used other works, third-party content, or other pre-existing elements (such as any audio, video, artwork, writing, graphics, or logos) in your Submission; (ii) no person, other than you and/or Sponsor has any right, title, or interest in any part

of your Submission; (iii) your Submission, the use thereof by Sponsor, or the exercise by Sponsor of any rights granted by you pursuant to these Official Rules and your entry, does not and will not infringe or violate any rights of any third party or entity, including, without limitation, copyright and trademark, or create claims for defamation, privacy and publicity, false light, idea misappropriation, intentional or negligent infliction of emotional distress, or any contractual rights; (iv) you have all the rights, licenses, permissions and consents necessary to submit the Submission and to grant all of the rights that you have granted to Sponsor pursuant to these Official Rules and necessary to submit your entry in accordance with these Official Rules; (v) you have obtained written permission when photographing any part of the Submission on private property not owned or controlled by you, where such permission is required and can provide Sponsor with copies; (vi) if your Submission depicts a person or persons under the age of eighteen (18), you are the minor(s)' parent or legal guardian; and (vii) you are a permanent legal U.S. resident physically residing in the fifty (50) United States and are over the age of eighteen (18) and are the age of majority in your state of residence as of the time of your Submission.

You represent and warrant that all persons who were engaged by you to work on the Submission in any manner have given you their express written consent to submit the Submission for use, exhibition and other exploitation in any manner and in any and all media, whether now existing or hereafter discovered, including, without limitation, the internet and television, throughout the world, in perpetuity. If you include any depiction (of any kind) of any actual person in or with your Submission, you must have their written permission to include their image in or with the Submission. You further represent and warrant that anyone who was engaged by you in connection with the Submission (i) has no claims for payment of any kind, including, without limitation, for royalties or residuals, arising out of any use, exhibition or other exploitation of the Submission; (ii) has no approval or consultation rights or any rights of participation with respect to any use, exhibition or other exploitation of the Submission; and (iii) was not engaged by you or anyone associated with the Submission under any union or guild agreement that results in any ongoing obligations resulting from the use, exhibition or other exploitation of the Submission.

Any Submissions containing material that is violent, pornographic or otherwise obscene, illegal, inappropriate or racially or morally offensive, or does not meet Sponsor's standards for any reason as determined by Sponsor, in its sole discretion, may be rejected as ineligible for consideration. Entries must comply with all laws, rules, and regulations including, but not limited to, those concerning copyright, plagiarism, trademark, defamation and invasion of privacy.

The Character Design will remain the property of the participant, but by entering and/or sending any Submission to Sponsor, you agree that: (i) all copies of Submissions become Sponsor's property and will not be returned; (ii) Sponsor has the right to utilize the Character Design in perpetuity in its sole discretion in its theme parks in general (including, but not limited to, during its annual Halloween Horror Nights event); (iii) post the Character Design on the USH website (including, but not limited to, the official USH website, the USH Facebook page, the official Universal CityWalk website, the Universal CityWalk Facebook page, the official Comcast website, the Comcast Facebook page, etc.), on YouTube and other websites that may be acting in partnership with USH or may be utilizing this material as part of publicity for the "Universal Studios Hollywood Halloween Horror Nights" event, and entrants grant these limited rights in perpetuity; and (iv) Sponsor and its licensees, successors and assigns have the right to use any and all Submissions, and the names, likenesses, voices, and images appearing in the Submission, for promotion and publicity of "Universal Studios Hollywood's Halloween Horror Nights" in any manner and in any medium now known or hereafter devised throughout the world in perpetuity. You waive any and all "moral rights" you may have in the Submission. You agree that you grant Sponsor these rights whether or not you are selected as a winner. **YOU WILL NOT BE PAID FOR YOUR SUBMISSION** or for granting Sponsor any of these rights.

Sponsor, their affiliates, and its licensees, successors and assigns are in no way obligated to use your Submission (and have no obligation to you or any other person or entity after your Submission is received), and you will not be given any credit if your Submission is used. Sponsor may elect to post any, all, or none of your Submission on the Website or elsewhere as set forth in these Official Rules. If Sponsor do elect to use your Submission or any part thereof, Sponsor may remove all or any part of it at any time for any or no reason, and Sponsor may use all or any part of it in any way that Sponsor elect, in its sole discretion. You agree to waive all claims to and shall not receive any

royalties of any kind now or in the future from Sponsor, their affiliates, or their licensees, successors and assigns for any use of your Submission, including copyright, trademark, public performance, digital sound recording, mechanical, synchronization or master use royalties, and you represent, warrant and agree that no other party is entitled to claim royalties from the use of the Submission as set forth in these Official Rules.

You acknowledge that your Submission will not be acknowledged and will not be returned. You acknowledge that this Submission is sent voluntarily and is not received or held "in confidence" and your Submission does not create a confidential relationship or obligation of secrecy between you and the Contest or Sponsor, any of their affiliates or any of their licensees, successors or assigns. You may not resell, assign or transfer any of your rights under these Official Rules.

You recognize that other persons, including Sponsor's own employees and other entrants, may have submitted to Sponsor or others, or made public, or may in the future originate and submit, or make public, similar or identical material that Sponsor may have the right to use, and that you will not be entitled to any compensation because of Sponsor's use of other similar or identical material. Nothing in this Agreement, or the submission of the Submission, shall be deemed to place you in any different position from any other member of the public with respect to the Submission.

4. **SELECTION OF FINALISTS AND WINNER:** Beginning as early as the start of the Submission Period, each eligible Submission will be reviewed by a panel of qualified judges selected by Sponsor and/or employees and/or representatives of Sponsor who will review Submissions on a rolling basis, as they are submitted. No Submissions received after July 1, 2013 at 5:01 PM EST will be reviewed. Each Character Design will be judged based equally on the following criteria: originality, degree of scariness and adhering to requirements. Five (5) Character Designs (the "Featured Submissions") will be selected by judges and posted on the Website for online voting (as described below) on or about July 2, 2013 along with the applicable entrant's first name, city, state and entry title. All potential Finalists selected by Sponsor will be required as a condition of continued eligibility to complete and sign an additional Affidavit of Eligibility, Waiver of Liability and Publicity Release, to read and sign these "Halloween Horror Nights – Character Design" Fan Contest Official Rules, and agree to allow Sponsor to attach the "Halloween Horror Nights" Logo to their Submission for future display on the Website or in any other media in perpetuity. Finalists may be notified by email, mail or phone and must return any and all documents required by Sponsor within the indicated time period. Any potential Finalist will not be considered as a Finalist if that person: (i) does not otherwise meet all eligibility requirements, as determined by Sponsor in its sole discretion or (ii) does not execute all agreements and/or releases required by Sponsor.

Sponsor may modify any Featured Submission, including editing, adding or subtracting elements at its sole discretion. If a potential Finalist or Winner does not make himself/herself available as directed by Sponsor or is otherwise not eligible, Sponsor reserves the right to disqualify such entrant and remove any Finalist, or Winner designation. All details of the designation as and use of a Featured Submission (including, but not limited to, the manner and duration of posting on the Website or on any other website or in any other venue) are at the sole discretion of the Sponsor. Sponsor, its affiliates, licensees, successors and assigns are in no way obligated to use any Submission in any manner. In the event that insufficient qualified entries are received, Sponsor reserves the right, in its sole discretion, to choose fewer than five (5) or not to choose any Featured Submissions.

**ONLINE VOTING:** On or about July 2, 2013 at 12:00 p.m. PT to July 8, 2013 at 11:59a.m. PT (the "Voting Period,") or on such other dates and at such other times as determined by Sponsor in its sole discretion, visitors to the Website may vote for their favorite Featured Submission according to the voting rules and procedures established by Sponsor, which will be posted on the Website. At the start of the Voting Period, each of the Featured Submissions will be posted on the Website in a randomized manner. After viewing the Featured Submissions, visitors may vote for their favorite Featured Submission online by following the provided instructions and according to the voting rules and procedures established by Sponsor, which will be posted on the Website. The Voting Period, voting rules and procedures and voting methods are subject to change, at Sponsor's sole discretion, and any changes will be posted on the Website. In the event of a tie, ties will be broken

as described above with respect to the judging of the Short Films. After the close of the Voting Period, Sponsor will have three (3) business days in which to initially contact the Winner, in its sole discretion, at either the telephone number and/or email address provided by Participant in their initial Submission. In the event Winner cannot be reached after two (2) attempts or is deemed ineligible, prize will be awarded to runner-up. In addition, Sponsor may publicly announce the name of the Winner during the 2013 "HHN Eyegore Awards" Ceremony at Universal Studios Hollywood, on September 20, 2013.

5. PRIZE: The winner selected will be designated as the prize winner ("Winner") on September 20, 2013 and will receive a prize consisting of the following: 1) two (2) tickets to the HHN Eyegore Awards ceremony in Universal City, California ; 2) round trip, coach class air transportation for Winner and a guest to the EyeGore awards in Universal City from the major airport closest to the Winner's home (as determined by Sponsor in its sole discretion) to Los Angeles, California (Winner will be responsible for ground transportation to/from the airport at point of origin)\*, and hotel accommodations, room and tax only, for up to two (2) people in a maximum of one (1) room at a hotel of USH's choosing in its sole discretion for three (3) consecutive days and two (2) nights (hotel accommodations do not include meals, incidentals, tips, telephone calls, or any other personal expenses incurred during the trip, not specified here) ; 3) a private tour of the costume and makeup department including the transformation of a live "scareactor" based on the winning Character Design; and 4) Winner will be recognized with a presentation of an Eyegore Certificate. The Winner's Character Design will debut in front of studio executives, celebrities and media that are in attendance at the Eyegore Awards. The Winner and his/her guest will receive two (2) tickets to enjoy 2013's "Halloween Horror Nights" at Universal Studios Hollywood. Estimated Retail Value of the Prize is Two Thousand and 00/100 Dollars (\$2000.00). \* For a winner who is a California resident, air transportation may be substituted with another method of transportation by Sponsor in its sole discretion.

All details of Prize will be determined by Sponsor in its sole discretion. Sponsor will furnish an Internal Revenue Service Form 1099 to Winner for the ERV of Prize for the tax year in which Prize was won. Travel arrangements must be made through Sponsor's agent, on a carrier of Sponsor's choice. Winner and guest must travel together on the same itinerary, including the same departure date and return date, and must have valid travel documents (e.g., valid government issued photo ID and/or passport) prior to departure. Failure to secure the necessary travel documents will result in forfeiture of Prize and time permitting, an alternate Winner may be selected from the remaining eligible Entries based on the Judging Criteria at Sponsor's sole discretion. All taxes and other expenses, costs, or fees associated with the acceptance and/or use of Prize are the sole responsibility of Winner. Prize cannot be transferred by Winner and is valid only for the items detailed above, with no substitution of Prize by Winner. Exact travel dates will be determined by Sponsor in their sole discretion. If Winner is unable to travel during the dates specified by Sponsor, Prize will be forfeited and time permitting, Sponsor may, in its sole discretion award Prize to an alternate Winner selected from among all remaining eligible entries based on the Judging Criteria. Travel and hotel arrangements will be determined by Sponsor in its sole discretion. Once determined, no change, extension, or substitution of travel dates and/or times is permitted, except by Sponsor in its sole discretion. Prize consists only of the elements set forth above. No other travel elements (including, without limitation, ground transportation (except as listed above), insurance, gasoline, meals, gratuities, and souvenirs) are included in Prize. All taxes and fees assessed at the time of ticketing are the responsibility of Winner. Tickets are non-refundable. Reservations are subject to availability. Tickets are not valid for business-related or group travel. Tickets are valid only for travel on airline chosen by Sponsor in its sole discretion. Tickets will be issued only to Winner and guest. Tickets are void if sold for cash or other consideration. Winner is responsible for any tax liability (including applicable departure taxes or fees, including baggage fees), inspection charges, and security charges. Once issued, tickets are non-transferable and may not be reissued once travel has commenced. Open tickets may not be issued and stopovers are not permitted. Travel may not be combined with any other offer and may not qualify for frequent flyer miles or hotel points. All travel will be at the risk of Winner and guest. Sponsor will not replace any lost or stolen tickets, vouchers, or certificates. All elements of Prize must be redeemed at the same time. In the event of an act of God or an unforeseen, uncontrollable event, Sponsor reserves the right to reschedule all travel for a later date.

6. ADDITIONAL ITEMS THAT MAY BE REQUIRED BY SPONSOR: Upon request, you will provide Sponsor with signed appearance releases and location agreements ("Design Agreements") as Sponsor may deem necessary in its sole discretion. Failure to Provide Sponsor with Film Agreements may result in disqualification. Additionally, upon request, you will provide Sponsor with

a hard copy (the "Master") of your Submission in the format requested by Sponsor. You acknowledge and agree that Sponsor shall have the right to edit and otherwise modify the Master and the Submission, in its sole discretion, including, without limitation, deleting and adding such materials as Sponsor deem necessary or desirable in its sole discretion.

Subject to time, telecast, and production exigencies, and in Sponsor's sole discretion, Sponsor will make arrangements for all or some portion (as solely determined by Sponsor) of the Winner's Character Design to be exhibited (the "Exhibition") during the currently scheduled HHN Eyegore Awards in September, 2013. All decisions regarding and details related to the Exhibition are at Sponsor's sole and exclusive discretion. The Exhibition has no cash value. (Sponsor may also, in its sole discretion, use, without limitation, post any entrant's Character Design on Sponsor's digital media outlets or other venues designated solely by Sponsor. There is no cash value to the selection or use by Sponsor in any manner or media whatsoever of any Submission of any entrant. No payment or compensation will be awarded for such exposure.

Any entrant selected as a Winner must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Prize is non-transferable, non-refundable and no substitutions will be permitted, except that Sponsor reserves the right to substitute prize(s) of comparable or greater value in the event of prize unavailability. All federal, state and local taxes are the sole responsibility of winners. If the Eyegore Awards and/or the Halloween Telecast in which the Exhibition is planned by Sponsor is cancelled, rescheduled or postponed for any reason prior at any time prior to or during the scheduled Exhibition, or in the event that any prize component is not available for any reason, then remaining elements of prize shall be awarded and shall constitute full satisfaction of Sponsor's prize obligation to any Winner and no additional compensation will be awarded.

Potential Winner will be notified by phone and/or email. Sponsor will make two (2) attempts to contact the potential Winner at the phone number or email address provided at the time of entry within seventy-two (72) hours from the time of the selection. If Sponsor is unable to reach potential Winner via phone or email within this time frame, he/she may be disqualified, any prize will be forfeited, and Sponsor may, in its sole discretion, award Prize to an alternate Winner selected from among all remaining eligible entries based on the Judging Criteria.

7. **GENERAL RULES:** Entry constitutes permission to the Sponsor and its designees to use each entrant's name, city, state, likeness, voice, biographical information and statements for purposes of advertising, promotion and publicity in any and all media, now or hereafter known, throughout the world in perpetuity without additional compensation, notification or permission, unless prohibited by law. If the Show, Halloween Telecast, and/or the contemplated Exhibition (or any other aspect of this Contest) is canceled for any reason or if for any reason this Contest is not capable of being run or implemented as planned, including, but not limited to, as the result of infection by computer viruses or bugs, tampering, unauthorized intervention, fraud, or any other cause of any kind, which, in Sponsor's sole judgment, is likely to or actually corrupts or affects the administration, security, fairness, integrity or proper conduct of the Contest, then Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend all or any part of the Contest, or to disqualify any implicated entrant(s) (and their entries), and the Prize (or any portion thereof) may not be awarded. In the event of cancellation, Sponsor reserves the right, at its sole discretion, to conduct judging and to award prize(s) for the applicable Contest Period from among all eligible, non-suspect entries received up to the time of the event or action warranting such cancellation, termination, modification or suspension, as applicable. Notice of cancellation, termination, modification or suspension, if any, may be posted on the Website.
